On December 11, 2008, the Board of Nursing issued an order removing the petitioner's stay of suspension and denying modification to the order of Board dated May 17, 2007. Due to an inadvertent scrivener's error, the order incorrectly indicated that the stay of suspension was to be removed. The motion of the Board did not affect the stay and it was to remain in effect. Based upon the language of the motion, the Board now issues this errata to correct the order as follows:

#### **ORDER**
