ORDER OF SUSPENSION

On June 27, 2007, the Pharmacy Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent, Bart Sheard, was to abstain from alcohol, drugs, and any items that might create a false positive drug screen.

On January 16, 2008, the Department of Regulation and Licensing received a confirmed positive alcohol screen submitted by Respondent on January 2, 2008.

On January 17, 2008, the board considered evidence that Bart Sheard (license number 40-9241), has not been in compliance with the board order as outlined in his Final Decision & Order by consuming alcohol.

ORDER

NOW, THEREFORE, IT IS ORDERED that the license of Bart Sheard, Rph (#40-9241), is hereby suspended effective immediately.
