PROCEDURAL HISTORY

The Wisconsin Medical Examining Board entered a Final Decision and Order in the above-captioned matter on August 20, 2008. The terms of the Order required that the Board appoint a qualified physician to serve as a proctor to observe two arthroscopically assisted ACL reconstructions performed by Michael C. Dussault, M.D. and to file a report with the Wisconsin Medical Examining Board describing and critiquing the surgical procedures and techniques utilized by Dr. Dussault when performing the two arthroscopically assisted ACL reconstructions.

Michael C. Dussault, M.D. has nominated Bradley Fideler, M.D., Mercy Walworth Medical Center, N2950 State Road 67, Lake Geneva, Wisconsin, 53147 to serve as the proctor. Sandra L. Osborn, the case advisor, and Gilbert C. Lubcke, attorney for the Department of Regulation and Licensing, Division of Enforcement, have joined with Dr. Dussault and his attorney, Paul Erickson, recommending that the Wisconsin Medical Examining Board appoint Bradley Fideler, M.D. to serve as the proctor.

The Wisconsin Medical Examining Board has reviewed the recommendations of the case advisor and of the parties to this action and has reviewed the qualifications of Bradley Fideler, M.D.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

Bradley Fideler, M.D. is appointed by the Wisconsin Medical Examining Board to serve as the proctor in the above-captioned matter and to execute his duties and responsibilities as more fully described in the Final Decision and Order, a copy of which is attached hereto

and incorporated herein.
