ORDER OF SUSPENSION

On August 30, 2007, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a nurse in Wisconsin was subject to Ms. Viilo undergoing an assessment and sign up for drug testing at a frequency of 56x/yr.

On May 6, 2008, the board considered evidence that Ms. Viilo has not been in compliance with the limitations on her license by failing to obtain an assessment and by failing to participate in random drug screens as outlined in the board order.

ORDER

NOW, THEREFORE, IT IS ORDERED that the license of Virginia Viilo, RN, (30-78818) is hereby suspended effective immediately.
