PROCEDURAL HISTORY

Ms. Thompson has made a request for a hearing in this case. An Administrative Law Judge has been assigned but no hearing has been set.

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Barbering and Cosmetology Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Stacy K. Thompson (Date of Birth: February 13, 1971) is duly licensed as a barbering and cosmetology manager in the state of Wisconsin (license #81-26902). That license was first granted on August 19, 1997, and is current through March 31, 2009. The last address Ms. Thompson reported to the Department of Regulation and Licensing (Department) is 2611 6th Street, Eau Claire, Wisconsin 54703. Stacy K. Thompson has been known as Stacy K. Rognholt in the past.
- 2. Ms. Thompson's barbering or cosmetology manager license was in expired status from July 1, 2007, through August 29, 2007.

- 3. Lagrande Salon, 303 South Barstow Street, Eau Claire, is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #80-31343). Stacy K. Thompson is listed with the Department of Regulation and Licensing as the manager of Lagrande Salon. As manager of a licensed barbering and cosmetology establishment, Stacy K. Thompson is responsible for compliance with Wis. Stats. Ch. 454 and Wisconsin Administrative Code Chs. BC 3 and 4.
- 4. An inspection of Lagrande Salon on August 28, 2007, by Investigator Willie Garrette of the Department found Ms. Thompson providing barbering and cosmetology services to a customer. At the time of the inspection, Ms. Thompson's barbering or cosmetology manager license was in expired status.
 - 5. Ms. Thompson has paid the Department \$325.00 in assessed costs in this matter.
- 6. In resolution of this matter, Stacy K. Thompson consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stats. Sec. 454.15.
- 2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached stipulation pursuant to Wis. Stats. Sec. 227.44(5).
 - 3. By the conduct referred to in the above Findings of Fact, Stacy K. Thompson has violated:
 - 1. Wis. Stats. sec. 454.04(1)(a). Except as permitted under pars. (b) and (d), no person may engage in barbering or cosmetology unless the person has received training in the areas of service provided and holds a current barber or cosmetologist license, manager license, temporary permit issued by the examining board or is an apprentice under s. 454.10 or a student in a barbering or cosmetology course of instruction.
 - 2. Wis. Admin. Code § BC 2.03(1). Licensees may provide only those services which they are competent to perform by training or experience and are licensed to provide.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Stacy K. Thompson f/n/a Stacy K. Rognholt (license number 81-26902) **is REPRIMANDED.**

IT IS ALSO ORDERED that Stacy K. Thompson f/n/a Stacy K. Rognholt shall pay costs in the amount of THREE HUNDRED TWENTY-FIVE dollars (\$325.00) in this matter.

Stacy K. Thompson f/n/a Stacy K. Rognholt has paid to the Department all costs associated with this Order.

This Order shall become effective upon the date of its signing.

It is hereby stipulated between Stacy K. Thompson f/n/a Stacy K. Rognholt and Claudia Berry Miran, Attorney for the Department of Regulation and Licensing, Division of Enforcement, as follows:

- 1. This Stipulation resolves a request for a hearing made by Ms. Thompson. Ms. Thompson consents to the resolution of this investigation by stipulation and without a hearing.
- 2. Ms. Thompson understands that by the signing of this Stipulation she voluntarily and knowingly waives her rights, including: the right to a hearing on the allegations against her, at which time the state has the burden of proving those allegations by a preponderance of the evidence; the right to confront and cross-examine the witnesses against her; the right to call witnesses on her behalf and to compel their attendance by subpoena; the right to testify herself; the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision; the right to petition for rehearing; and all other applicable rights afforded to her under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes and the Wisconsin Administrative Code.
 - 3. Ms. Thompson has been provided an opportunity to obtain legal counsel prior to signing this stipulation.
- 4. Ms. Thompson agrees to the adoption of the attached Final Decision and Order by the Barbering and Cosmetology Examining Board. The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Ms. Thompson waives all rights to any appeal of the attached order, if adopted in the form as attached.
- 5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall be returned to the Division of Enforcement for further proceedings. In the event that this Stipulation is not accepted by the
- Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.
- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Enforcement and any member of the Barbering and Cosmetology Examining Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Ms. Thompson or her attorney, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with the Board's deliberations on the Stipulation. Additionally, any such case advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.
- 7. Ms. Thompson is informed that should the Board adopt this stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department policy.
 - 8. The Division of Enforcement joins Stacy K. Thompson f/n/a Stacy K. Rognholt in recommending the Board
