On July 16, 2008, the Medical Examining Board considered the petitioner's request for assistance in locating a course to satisfy his remedial education order with sufficient time to comply with the order. Based upon the information presented, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request submitted by ALEJANDRO M. VINLUAN, M.D. (lic. # 14421) is hereby GRANTED as follows:

- 1. Petitioner is advised to contact the UW Continuing Medical Education program for possible development of an individualized course on the required topic (informed consent with an emphasis on the provision of adequate information to the patient).
- 2. The Board liaison shall be granted discretion to consider alternate or related courses which are submitted for preapproval by the petitioner if he is unable to obtain a course on the required topic to fulfill the order.
- 3. The petitioner shall be granted additional time until December 31, 2008 to complete his required remedial education.

This Order is effective upon the date of signing.
