ORDER REMOVING STAY OF SUSPENSION

On November 8, 2007, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a registered nurse in Wisconsin was suspended for an indefinite period. The Order provided that the suspension was stayed upon respondent's compliance with certain conditions and limitations on his license.

On March 14, 2007, the board considered evidence that Ms. Devine had not been in compliance with the limitations on her license by not calling in for her random drug screens. Accordingly, the board revokes the stay of suspension. The suspension is hereby reinstated effective immediately.

NOW, THEREFORE, IT IS ORDERED that the license of PAMELA DEVINE (30-132348), is suspended indefinitely.
