ORDER OF SUSPENSION

On October 17, 2007, the Medical Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent, Michael Moore, was to remain abstinent from drugs and alcohol.

On January 2, 2008, the board considered evidence that Michael Moore, M.D., has not been in compliance with the board order by testing positive for alcohol and not following the stipulated board order.

## **ORDER**

NOW, THEREFORE, IT IS ORDERED that the license of Michael Moore, (#20-41338), is hereby suspended effective immediately. Respondent must show three months compliance with all the terms and conditions of the Final Decision & Order prior to petitioning the board for reinstatement of his stay of suspension.

This order is effective January 3, 2008.
