On November 5, 2007, the Hearing and Speech Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent, Kristine Beland Trayser, was to remain abstinent from drugs and alcohol.

On May 8, 2008, the board considered evidence that Kristine Beland Trayser., has not been in compliance with the board order by testing positive for cocaine and not following the stipulated board order.

ORDER

NOW, THEREFORE, IT IS ORDERED that the license of Kristine Beland Trayser, (#1262), is hereby suspended effective May 9, 2008. Respondent must show six months compliance with all the terms and conditions of the Final Decision & Order prior to petitioning the board for reinstatement of her stay of suspension.
