OF SUSPENSION

On November 29, 2007, the Physical Therapists Affiliated Credentialing Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a physical therapist in Wisconsin was suspended and stayed, conditioned upon respondent's compliance with specified terms and conditions. Included among these respondent was to submit to random drug screens, provide quarterly work and therapy reports, and pay the assessed costs.

On April 2, 2008, the board considered evidence that Mr. Voelz has not been in compliance with the board's requirements.

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the license of JOHN T. VOELZ, P.T., (license #9593) is hereby suspended effective immediately. Respondent must show three months compliance with all the terms and conditions of the Final Decision & Order prior to petitioning the board for a stay of suspension.
