On September 4, 2008, the Board of Nursing considered the petitioner's request for modification of the Board order dated February 28, 2008, to decrease her random drug screens and to allow her employment in an agency setting. Based upon the information presented which shows that the petitioner has not been in compliance with her Board order, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modifications to the limitations upon the license of JUDI L. OLSON, R.N. (#94686) is DENIED.

IT IS FURTHER ORDERED that the petitioner must have one year of satisfactory compliance with terms and conditions of the Board order prior to consideration of a petition for modifications.
