ORDER FIXING COSTS

On October 2, 2008, the Board of Nursing filed its Final Decision and Order in the above-captioned matter by which the board ordered that pursuant to sec. 440.22, Wis. Stats., the costs of this proceeding be assessed against respondent. Pursuant to sec. RL 2.18 (4), Wis. Admin. Code, on or about October 6, 2008, the Board of Nursing received the Affidavits of Costs in the amount of \$652.92, filed by Attorney Arthur K. Thexton. On or about October 3, 2008, the Board of Nursing received the Affidavit of Costs of the Office of Legal Counsel in the amount of \$862.50, filed by Administrative Law Judge Ruby Jefferson-Moore. The Board of Nursing considered the Affidavits of Costs on November 6, 2008, and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that pursuant to sec. 440.22, Wis. Stats., the costs of this proceeding in the amount of \$1,515.42, set forth in the Affidavits of Costs of Attorney Arthur K. Thexton and Administrative Law Judge Ruby Jefferson-Moore, which are attached hereto and made a part hereof, are hereby assessed against respondent, and shall be payable by respondent to the Department of Regulation and Licensing. **Failure of respondent to make payment on or before December 6, 2008, shall constitute a violation of the Order unless respondent petitions for and the board grants a different deadline.** Under sec. 440.22 (3), Wis. Stats., the Department of Regulation and Licensing may not restore, renew or otherwise issue any credential to the respondent until respondent has made payment to the department in the full amount assessed.
