### **PROCEDURAL HISTORY**

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Stipulation comes after the issuance of a barbering and cosmetology citation. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

### **FINDINGS OF FACT**

- 1. Susan E. Larson, d/o/b: 01/23/47, is duly licensed as a barbering and cosmetology manager in the state of Wisconsin having license #081-13742. This license was first granted on 10/12/76.
- 2. Mr. Larson's last known reported business address on file with the Department of Regulation and Licensing ("Department") is: 1215 Belknap Street, Superior, Wisconsin 54880.
  - 3. Elisans Hair Design ("Elisans) is duly licensed as a barbering and cosmetology establishment in the state of

Wisconsin having license #080-16277. This license was first granted on 03/04/86.

- 4. Elisans' last known reported business address on file with the Department of Regulation and Licensing ("Department") is: 1215 Belknap Street, Superior, Wisconsin 54880.
- 5. Ms. Larson is listed as the owner of Elisans. At all times relevant to the facts stated below, Ms. Larson is responsible for compliance with chapter 3 of the Wisconsin Administrative Code.
- 6. On or about September 18, 2007 an inspection of Elisans was conducted by a Department investigator. The inspection revealed the salon was not being maintained in an orderly and sanitary condition. Based on the results of the inspection, Ms. Larson received a barbering and cosmetology citation.
- 7. In resolution of this matter, Ms. Larson and Elisans consent to the entry of the following Conclusions of Law and Order.

#### **CONCLUSIONS OF LAW**

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. Sec. 454.15, and the Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached stipulation pursuant to Wis. Stat. Sec. 227.44(5).
- 2. By the conduct referred to in the above Findings of Fact, Susan E. Larson and Elisans Hair Design have violated:

Wis. Admin. Code § BC 3.01(1) for failing to maintain an orderly and sanitary salon.

### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that the Respondents shall jointly and severally pay a FORFEITURE of ONE HUNDRED dollars (\$100.00).

IT IS FURTHER ORDERED, that the Respondents shall jointly and severally pay COSTS in this matter in the amount of THIRTY dollars (\$30.00).

IT IS FURTHER ORDERED, that payment of SIXTY FIVE dollars (\$65.00) will paid within 30 days from the date of this Order and a second payment of SIXTY FIVE dollars (\$65.00) will be paid thirty (30) days from the previous payment. The total of amount of ONE HUNDRED THIRTY DOLLARS (\$130.00) must be paid sixty (60) days from the date of this Order

IT IS FURTHER ORDERED, that in the event that if Respondents fail to timely submit payment of the forfeiture and costs as set forth above, Susan E. Larson's, barbering and cosmetology manager's license #081 0013742 and Elisans Hair Design barbering and cosmetology establishment license #080 0016277 **SHALL BE SUSPENDED**, without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said partial costs has been paid to the Department of Regulation and Licensing and their failure to pay the costs shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED, that file, 07 BAC 185 be, and hereby is, closed as to all Respondents.
