A Petition for an Administrative Injunction was filed with the Department of Regulation and Licensing (“Department”) on April 22, 2008. Prior to the hearing on the Petition, the parties in this matter agreed to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed the attached Stipulation and considers it acceptable. Accordingly, the Department adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Derrick D. Washington was issued a Barbering and Cosmetology apprenticeship permit on December 17, 1999, but the permit expired on December 17, 2003 and as of July 24, 2008, Mr. Washington did not hold a Barbering and Cosmetology license in the State of Wisconsin.
2. Mr. Washington’s most recent address on file with the Department of Regulation and Licensing is as an employee of Sheer Elegance at 330 West Lakeside Street in Madison. Sheer Elegance is no longer in operation and its license is expired.
3. Mr. Washington’s current business card lists his address as Genesis International, 2923 E. Washington Ave., Madison, WI 53704.

4. Genesis International was issued a license as a Barbering and Cosmetology establishment at **2617** East Washington Avenue in Madison on March 28, 2007 but it expired on June 30, 2007 and it has not been renewed.

5. On April 11, 2008, Department investigator Greg Raube noted that a Barbering and Cosmetology establishment named Genesis International was open for business at **2923** East Washington Avenue in Madison.

6. On April 17, 2008, Department investigator Kelley Sankbeil visited Genesis International at 2923 East Washington Avenue, observed that the establishment was open for business, that Mr. Washington was performing barbering services on a patron, and that no licenses were posted other than the expired license for Genesis International at 2617 E. Washington Avenue. Mr. Washington identified himself as the owner of the establishment.

#### CONCLUSIONS OF LAW

A. The Wisconsin Department of Regulation and Licensing has jurisdiction to act in this matter, pursuant to sections 440.21, 454.04 and 454.08 of the Wisconsin Statutes, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. sec. 227.44(5).

B. Derrick D. Washington practiced Barbering and Cosmetology without a license, contrary to section 454.04 of the Wisconsin Statutes.

C. Genesis International operated as a Barbering and Cosmetology establishment, contrary to section 454.08 of the Wisconsin Statutes.

#### ORDER

NOW, THEREFORE, THE DEPARTMENT OF REGULATION AND LICENSING ISSUES THE FOLLOWING SPECIAL ORDER OF INJUNCTION:

**I. The Respondent, Derrick D. Washington, is enjoined administratively from practicing Barbering and Cosmetology in Wisconsin without a license issued by the Department of Regulation and Licensing.**

**II. The Respondent, Genesis International, is enjoined administratively from operating as a Barbering and Cosmetology establishment in Wisconsin without a license issued by the Department of Regulation and Licensing.**

Following the issuance of a Special Order of Injunction, any person who violates the Order may be required to forfeit \$10,000 for each offense, and each day of continued violation constitutes a separate offense.
