PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable. Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Leo M. Ognen, M.D. (DOB 03/28/1952) is duly licensed to practice medicine and surgery in the state of Wisconsin (license #20-36356). This license was first granted on February 24, 1995. Dr. Ognen's specialty is family practice.
- 2. Respondent's most recent address on file with the Wisconsin Medical Examining Board is 2835 W. Seaton Circuit Street, Warren, MI 48091.
- 3. At all times relevant to this action, Respondent was working as a physician primarily in the State of Ohio.
- 4. On November 7, 2007, Respondent entered into a Plea Agreement with the United States District Court for the Western Division of the Northern District of Ohio, wherein he pled guilty to Counts 2 through 26 of the Indictment that he knowingly and intentionally distributed and dispensed and caused to be distributed and dispensed, outside the usual course o medical practice and for other than a legitimate medical purpose, Oxycodone, a Schedule II controlled substance in the form o OxyContin. A true and correct copy of the Plea Agreement is attached to this document as Exhibit A. Exhibit A i incorporated into this document by reference.

5. As part of this Plea Agreement, Respondent has agreed to permanently surrender his license to practice medicine and surgery in the State of Wisconsin (license #20-36356).

CONCLUSIONS OF LAW

- 1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter, pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).
- 2. The facts provided in paragraph 4, above, constitute a violation of Wisconsin Administrative Code § Med 10.02(2)(r).

ORDER

NOW, THEREFORE, IT IS ORDERED that:

1. The Wisconsin Medical Examining Board accepts the VOLUNTARY SURRENDER of Leo M. Ognen's license (license #20-36356), to practice medicine and surgery in the State of Wisconsin, effective the date of this Order.

IT IS FURTHER ORDERED that:

- 2. Dr. Ognen shall not request reinstatement or reapply for a license to practice medicine and surgery in the State of Wisconsin at any time in the future.
- 3. The pending investigation, 08 MED 037, shall be, and hereby is, closed without further proceedings.

This Order shall become effective on the date of its signing.
