#### **PROCEDURAL HISTORY**

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Barbering and Cosmetology Examining Board. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### **FINDINGS OF FACT**

- 1. Chevonna Hyche-Davis, (DOB 05/08/1977) is duly licensed as a barbering and cosmetology manager in the State of Wisconsin (license # 28745-81). This license was first granted on June 25, 2001.
- 2. Respondent's most recent address on file with the Department of Regulation and Licensing (hereafter Department) is W 155 N5316 Sharptail Court, Menomonee Falls, Wisconsin 53051.
- 3. On March 5, 2008, Investigator Kelley Sankbeil inspected the premises located at 3900 West Brown Deer Road, Milwaukee, Wisconsin 53209.
- 4. During her inspection, Investigator Sankbeil inspected the booth rented by Respondent on the premises.
- 5. Respondent did not have an establishment license for her booth.
- 6. Respondent applied for an establishment license on March 6, 2008. The license, # 35777-80, was issued on March 19, 2008, and expires on March 31, 2009.

### **CONCLUSIONS OF LAW**

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stats. § 454.15 (2), and is authorized to enter into the attached Stipulation and Order pursuant to Wis. Stats. § 227.44 (5).
- 2. Wis. Stat. § 454.15 (2) (i) states that a violation of chapter 454 or of the rules promulgated under chapter 454 is cause for discipline.

3. The conduct described in paragraph(s) 5, above constitutes a violation of Wis. Administrative Code § BC 3.02 (2) (b), which provides that lessees of chairs or booths shall hold both a manager license and an establishment license.

#### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED:

The license of Chevonna Hyche-Davis (#28745-81) to practice barbering and cosmetology in the State of Wisconsin is hereby REPRIMANDED.

IT IS FURTHER ORDERED that Chevonna Hyche-Davis shall pay to the Department of Regulation and Licensing a forfeiture of SEVEN HUNDRED dollars (\$700.00).

IT IS ALSO ORDERED that Chevonna Hyche-Davis shall pay costs in the amount of ONE HUNDRED dollars (\$100.00) in this matter.

Respondent shall make eight (8) payments of ONE HUNDRED dollars (\$100.00), with the first payment being on July 1, 2008, and the remaining payments being three months apart. Payment shall be made by **certified check or money order** payable to the Wisconsin Department of Regulation and Licensing, and mailed to:

In the event Respondent fails to submit timely any payment of the forfeiture as set forth above, or fails to pay costs as ordered, Respondent's license (#28745-81) SHALL BE SUSPENDED, without further notice or hearing until Respondent has complied with the terms of this Order.
