PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Stipulation comes after the issuance of a barbering and cosmetology citation. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Anthony V. Leto, d/o/b: 03/09/74, is duly licensed as a barbering and cosmetology manager in the state of Wisconsin having license #081-31669. This license was first granted on 05/21/07.
2. Mr. Leto's last known reported business address on file with the Department of Regulation and Licensing ("Department") is: 2340 S. Kinnickinnic Avenue, Milwaukee, Wisconsin 53207.
3. At all times relevant to the facts stated below, Mr. Leto was responsible for compliance with chapter 454 of the Wisconsin Statutes and chapters 2 and 3 of the Wisconsin Administrative Code.
4. On or about February 21, 2008, an inspection at a salon named Razor LLC was conducted by a Department investigator. The inspection revealed that barbering services were being provided without first obtaining an establishment license. Mr. Leto is the owner and manager of record for Razor LLC.
5. A barbering and cosmetology citation was issued to Mr. Leto in regards to the violation found during the

inspection.

6. On or about February 26, 2008, Razor LLC was granted a barbering and cosmetology establishment license (#80-35705).

7. Mr. Leto immediately took action to correct the unlicensed establishment violation by obtaining a barbering and cosmetology establishment license within five days of the Department inspection.

8. In resolution of this matter, Anthony V. Leto consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. Sec. 454.15, and the Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached stipulation pursuant to Wis. Stat. Sec. 227.44(5).

2. By the conduct referred to in the above Findings of Fact, Anthony V. Leto has violated:
Wis. Stat. § 454.08(1)(b); and Wis. Admin. Code §§ BC 2.04(1); 2.045(1); 3.01(1) by providing barbering services in an unlicensed establishment.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that the Respondent, Anthony V. Leto shall pay a FORFEITURE AND COSTS of FIVE HUNDRED dollars (\$500.00).

IT IS FURTHER ORDERED, that a payment of TWO HUNDRED FIFTY dollars (\$250.00) will be paid within 30 days from the date of this Order and a second payment of TWO HUNDRED FIFTY dollars (\$250.00) will be paid thirty (30) days from the previous payment. The total of amount of FIVE HUNDRED dollars (\$500.00) must be paid sixty (60) days from the date of this Order.

IT IS FURTHER ORDERED, that in the event that if the Respondent, Anthony V. Leto fails to timely submit payment of the forfeiture and costs as set forth above, Anthony V. Leto's, barbering and cosmetology manager's license #081 0031669 **SHALL BE SUSPENDED**, without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said partial costs has been paid to the Department of Regulation and Licensing and their failure to pay the costs shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED, that file, 08 BAC 064 be, and hereby is, closed as to the Respondent.
