PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Michael A. Snyder (Date of Birth: September 28, 1948) is duly licensed as a Private Security Person in the state of Wisconsin (Permit #108-32994) by the Wisconsin Department of Regulation and Licensing (Department). The permit was first issued on March 14, 2007, and is current through August 31, 2008. Mr. Snyder's last address reported to the Department is 6578 North Crestwood Drive, Glendale, Wisconsin 53209. The Department has found that Mr. Snyder currently resides at 2155 North Grace Boulevard, Number 206, Chandler, Arizona 85225.

2. Mr. Snyder has admitted to the Department that he worked for two weeks without a private security permit while employed at SSA Security, Inc., d/b/a Silverhawk Security.

3. Mr. Snyder is in ill health and wishes to surrender his Private Security Permit.

4. In resolution of this matter, Michael A. Snyder consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Department of Regulation and Licensing is authorized to enter in the attached Stipulation pursuant to Wis. Stat. sec. 227.44(5).

2. By the conduct referred to in Findings of Fact 2., Michael A. Snyder has violated Wis. Stat. sec. 440.26(1)(a)2. No

person may do any of the following unless he or she has a license or permit issued under this section:

2. Act as a private detective, investigator, special investigator or private security person.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that the Wisconsin Department of Regulation and Licensing accepts the SURRENDER of the Private Security Permit of Michael A. Snyder (Permit #108-32994).

Within 30 days of the effective date of this Order, Mr. Snyder shall send all indicia of licensing to:

It is hereby stipulated between Michael A. Snyder, and Claudia Berry Miran, attorney for the Department of Regulation and Licensing, Division of Enforcement, as follows:

1. This Stipulation is entered into as a result of a pending investigation of Mr. Snyder's licensure by the Division of Enforcement (07 RSG 010). Mr. Snyder consents to the resolution of this investigation by Stipulation and without the issuance of a formal complaint.

2. Mr. Snyder understands that by signing this Stipulation he voluntarily and knowingly waives his rights, including: the right to a hearing on the allegations against him, at which time the state has the burden of proving those allegations by a preponderance of the evidence; the right to confront and cross-examine the witnesses against him; the right to call witnesses on his behalf and to compel their attendance by subpoena; the right to testify himself; the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision; the right to petition for rehearing; and all other applicable rights afforded to him under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Mr. Snyder has been provided the opportunity to obtain legal counsel prior to signing this Stipulation.

4. Mr. Snyder agrees to the adoption of the attached Final Decision and Order by the Department of Regulation and Licensing (Department). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Mr. Snyder waives all rights to any appeal of the Department's order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Department, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division of Enforcement for further proceedings. In the event that the Stipulation is not accepted by the Department, the parties agree not to contend that the Department has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Enforcement may appear before the Department in open or closed session, without the presence of Mr. Snyder or Mr. Snyder's attorney, for purposes of speaking in support of this agreement and answering questions that the Department may have in connection with the Department's deliberations on the Stipulation.

7. Mr. Snyder is informed that should the Department adopt this Stipulation, the Department's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. The Division of Enforcement joins Michael A. Snyder in recommending the Department adopt this Stipulation and issue the attached Final Decision and Order.
