PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the [Licensing Authority]. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Stacy A. Keuler Pautz, LPN, (DOB 02/16/1971) is duly licensed as a licensed practical nurse] in the state of Wisconsin (license # 34238). This license was first granted on July 14, 1997.
2. Respondent's most recent address on file with the Wisconsin Board of Nursing is 622 Millbrook Drive, Neenah, Wisconsin 54956.
3. At all times relevant to this action, Respondent was working as licensed practical nurse at Affinity Medical Group, 618 Memorial Drive, Shilton, Wisconsin.
4. On January 16, 2004, Respondent put a prescription order for Clomiphene Citrate for herself into Wellnix under the name of a nurse practitioner. Respondent then cancelled the prescription order because the advanced prescriber nurse practitioner refused to order it.

5. On January 16, 2004, Respondent put a prescription order for Clomiphene Citrate for herself into Wellnix under the name of a physician. The physician was not asked by the Respondent to order the medication.
6. On January 16, 2004, Respondent picked up the prescription from Walmart pharmacy.
7. Respondent is not currently employed as a nurse and has not been employed as a nurse since 2005.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).
2. The conduct described in paragraph(s) #4-6, above, constitutes a violation of Wisconsin Administrative Code § N 7.04(2).
3. The Wisconsin Board of Nursing has the authority to assess costs pursuant to § 440.22 (2), Stats.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The license of Stacy A. Keuler Pautz, LPN, to practice as a licensed practical nurse in the State of Wisconsin is hereby REPRIMANDED.
2. Stacy A. Keuler Pautz, LPN must notify the Board at least 30 days prior to resuming the practice of nursing and shall comply with the following terms and conditions:
 - A.) Stacy A. Keuler Pautz's license is LIMITED whereby she will not be allowed to work in a capacity which would allow her to enter prescriptions by computer or telephone for a period of one (1) year.
 - B.) Stacy A. Keuler Pautz is required to provide supervising nurse work reports on a quarterly basis for a period of one (1) year.

IT IS FURTHER ORDERED that:

3. Respondent shall, within thirty (30) days from the resumption of practice, pay costs of this proceeding in the amount of six hundred twenty-five (\$625.00) dollars. Payment shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed to:

4. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit any payment of the forfeiture as set forth above, (or fails to pay costs as ordered or fails to comply with the ordered continuing education) the Respondent's license(#34238) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.

5. This Order is effective on the date of its signing.
