PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Veterinary Examining Board. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Chester C. Swanson, D.V.M., ("Respondent") was born on December 15, 1935, and is licensed to practice veterinary medicine in the state of Wisconsin pursuant to license number 50-857. This license was first granted on January 1, 1965.
2. Respondent's most recent address on file with the Wisconsin Veterinary Examining Board is W5869 Creek Road, Random Lake, Wisconsin 53075-1225.
3. At all times relevant to this proceeding, Respondent was working as a veterinarian at Random Lake, Wisconsin.
4. The Division of Enforcement, Department of Regulation and Licensing, is investigating a complaint alleging improper surgical treatment of a cat by Respondent.
5. Respondent has decided to retire from the practice of veterinary medicine and has tendered the surrender of license to practice veterinary medicine.

CONCLUSIONS OF LAW

1. The Wisconsin Veterinary Examining Board has jurisdiction to act in this matter, pursuant to Wis. Stat. § 453.07 and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The Veterinary Examining Board accepts the SURRENDER of the license previously issued to CHESTER C. SWANSON, D.V.M.
2. This Order is effective on the date of its signing.
