PROCEDURAL HISTORY

The Wisconsin Medical Examining Board entered a Final Decision and Order in the above-captioned matter on August 20, 2008. The terms of the Order required that the Board approve continuing education courses in obstetrics which emphasize the recognition and management of obstetric emergencies.

Michael A. Dehner, M.D. has requested that the Board review and approve the following courses in obstetrics for the credits indicated:

Advanced Life Support in Obstetrics (14.5 credits) sponsored by the Hennepin County Medical Center Department of Family and Community Medicine (September 11 – 12, 2008; St. Paul, Minnesota).

The Art of Clinical Obstetrics (16.0 credits) sponsored by the American College of Obstetrics and Gynecology (December 4 – 6, 2008; New York, New York).

The Wisconsin Medical Examining Board has reviewed the descriptive materials for the above referenced courses and considered the recommendations of the case advisor and of the parties to this action.
