PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Barbering and Cosmetology Board ("Board"). The Board has reviewed this Stipulation and considers it acceptable. Accordingly, the Board adopts the attached Stipulation in this matter and makes the following Findings of Fact, Conclusions of Law, and Order:

FINDINGS OF FACT

1. Anh Tan Vo is licensed in the State of Wisconsin as a Manicurist having license number 85-3931, first granted on October 12, 1999. Mr. Vo's most recent address on file with the Department of Regulation and Licensing ("Department") is 463 Ventura Lane, Whitewater, WI 53190.

2. Mr. Vo is the owner of Star Nails, 301 Madison, Fort Atkinson, WI 53538. Mr. Vo was and is responsible for compliance with chapter 454 of the Wisconsin Statutes and chapter BC 2 of the Wisconsin Administrative Code.

3. On May 7, 2008, Departmental Investigator Michelle Krisher conducted an inspection of Star Nails. The inspection revealed that an unlicensed person was providing manicuring services, which is a violation of section BC 2.04 (1) of the Wisconsin Administrative Code, and Ms. Krisher issued a barbering and cosmetology citation to Mr. Vo as the owner of Star Nails. The citation carried a forfeiture and costs of \$1000.

4. Ms. Krisher noted and explained, but did not issue a citation for, a practice area which was not in compliance, but which was brought into compliance during the inspection.

5. Mr. Vo is unable to pay the entire \$1,000 forfeiture at one time.

6. In resolution of this matter, Mr. Vo consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Barbering and Cosmetology Board has jurisdiction to act in this matter pursuant to section 454.15 of the Wisconsin Statutes and is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.
2. Respondent Anh Tan Vo is subject to discipline for the violations in Finding of Fact 3 above.

ORDER

NOW, THEREFORE, IT IS ORDERED that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that the Respondent, Anh Tan Vo, shall pay the forfeiture and costs of \$1,000.00, as follows: The Respondent shall pay no less than \$250.00 by October 1, 2008, with additional payments of \$250.00 due on the following dates: January 1, 2009; April 1, 2009; and July 1, 2009.

In the event that the Respondent fails to timely submit payment of the forfeiture and costs as set forth above, his Manicurist license **SHALL BE SUSPENDED**, without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of the forfeiture and costs has been paid to the Department of Regulation and Licensing.

IT IS FURTHER ORDERED that file 08 BAC 094 be closed.
