PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department.

The Department has reviewed this Stipulation and considers it acceptable. Accordingly, the Department in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order:

FINDINGS OF FACT

1. Kevin Lee Skattebo holds permit 33471-108 as a Private Security Person in the state of Wisconsin. The permit was first granted on May 31, 2007 and is current until August 31, 2008.
2. Mr. Skattebo’s last address reported to the Department is 2000 Johnson Drive, Lot 108, Manitowoc, WI 54220
3. On October 8, 2007 Mr. Skattebo was convicted in Sheboygan County, Wisconsin Circuit Court of one count of misdemeanor battery.

CONCLUSIONS OF LAW

1. The Wisconsin Department of Regulation and Licensing is authorized to enter in the attached Stipulation pursuant to section 227.44 (5) of the Wisconsin Statutes.
2. By being convicted of a misdemeanor, Kevin Lee Skattebo is subject to discipline under section 440.26 (6) (a) of the Wisconsin Statutes: “... the department may reprimand the holder of a license or permit issued under this section or revoke, suspend or limit the license or permit of any person who has ... Been convicted of a misdemeanor or found to have violated any state or local law that is punishable by a forfeiture, subject to ss. 111.321, 111.322 and 111.335.”

ORDER

1. NOW, THEREFORE, IT IS HEREBY ORDERED that the attached Stipulation is hereby accepted.
2. IT IS FURTHER ORDERED that Kevin Lee Skattebo is hereby reprimanded.
3. IT IS FURTHER ORDERED that Kevin Lee Skattebo shall pay full costs in the amount of \$309.73 in this matter. All payments shall be submitted within 120 days from the date of this order. Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to:

In the event Mr. Skattebo fails to pay the costs within the time and in the manner as set forth above, his Private Security Permit shall be suspended without further notice, without further hearing, and without further Order of the Board, and said suspension shall continue until the full amount of said costs have been paid to the Department of Regulation and Licensing.

4. IT IS FURTHER ORDERED that file 07 RSG 064 be closed.
