PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Susan A. McAllister, date of birth 08/06/59, is duly licensed as a barbering and cosmetology manager in the State of Wisconsin having license #081-17393. This license was first granted on 05/05/86.
2. Ms. McAllister's most recent address on file with the Department is: 306 W. Fulton Street, Waupaca, Wisconsin 54981.
3. Department records indicate that Ms. McAllister is listed as the owner and manager of record for The Mane Event. The Mane Event is duly licensed as a barbering and cosmetology establishment in the State of Wisconsin having license #080-28291. This license was granted on 05/27/99.
4. As manager of record, Ms. McAllister was and is at all times relevant to this action responsible for compliance with Wisconsin Statutes, Chapter 454 and the Wisconsin Administrative Code for Barbering and Cosmetology Chapter 2 and 3.

5. On or about November 28, 2007, the Department's investigative staff conducted an inspection of The Mane Event. The Mane Event was being conducted during the Department's Barbering and Cosmetology Initiative. The inspection revealed that The Mane Event had been operating with an expired license. Ms. McAllister was notified that The Mane Event's license was expired and needed to be renewed immediately. The establishment license was subsequently renewed.

6. In resolution of this matter, Susan A. McAllister consents to the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15.

2. The Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

3. Respondent Susan A. McAllister has violated:

Wis. Stat. § 454.08 (1)(b) and Wis. Admin. Code §§ BC 2.04 (1); 2.045; and 3.01(1) by operating The Mane Event with an expired credential.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that the Respondent is hereby **REPRIMANDED** for the violations set forth above.

IT IS FURTHER ORDERED, that Respondent shall jointly and severally pay to the Department of Regulation and Licensing a forfeiture of **FIVE HUNDRED DOLLARS (\$500.00)**.

IT IS FURTHER ORDERED, that Respondents shall jointly and severally pay costs in this matter in the amount of **FIVE HUNDRED DOLLARS (\$500.00)**.

IT IS FURTHER ORDERED, that two payments of **FIVE HUNDRED DOLLARS (\$500.00)** shall be submitted every sixty (60) days from the dating and signing of this Order. A total payment of **ONE THOUSAND DOLLARS (\$1,000.00)** must be submitted. Payments shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED, that in the event that Susan A. McAllister fails to timely submit payment of the forfeiture and costs as set forth above, Susan A. McAllister's license (# 081 017393) **SHALL BE SUSPENDED**, without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said costs has been paid to the Department of Regulation and Licensing and their failure to pay the costs shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED, that file 07 BAC 254, be and hereby is, closed as to Susan A. McAllister.
