RESPONDENT. :

1. Jan's Hair Designs is duly licensed as a barbering and cosmetology establishment in the State of Wisconsin having license #080 32272. This license was granted on 08/26/04.
2. Jan's Hair Designs' most recent address on file with the Department of Regulation and Licensing ("Department") is: 139 Diagonal Street, Dodgeville, WI 53533.
3. Donna J. Tallard, date of birth: 12/26/44, is listed as a barbering and cosmetology manager at Jan's Hair Designs, having license #081-9291. This license was first granted on 02/14/67.
4. Ms. Tallard's most recent business address on file with the Department is: 139 Diagonal Street, Dodgeville, Wisconsin 53533.
5. As a licensee, Ms. Tallard was and is at all times relevant to this action responsible for compliance with

6. On or about September 25, 2007, a Department consumer protection investigator conducted an inspection of Jan's Hair Designs. The inspection was conducted as part of the Wisconsin Barbering and Cosmetology Inspection Initiative. The inspection revealed Ms. Tallard had not obtained a new establishment license for her current booth rental establishment, Donna J. Tallard (#80-35358; granted: October 12, 2007).

7. In resolution of this matter, the Respondent consents to the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15.

2. The Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

3. Respondent Donna J. Tallard has violated:

Wis. Stat. 454.15(2)(c) and Wis. Admin. Code §§ BC 2.04(1); 2.045(1); 2.07(1r) and 3.01(1) by operating a booth rental establishment within Jan's Hair Designs without first obtaining an establishment credential.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondent is hereby **REPRIMANDED** for the violations set forth above.

IT IS FURTHER ORDERED, that Respondent, Donna J. Tallard shall pay to the Department of Regulation and Licensing a forfeiture of **FIVE HUNDRED DOLLARS (\$500.00)**. Two installment payments of **TWO HUNDRED FIFTY DOLLARS (\$250.00)** shall be paid every sixty (60) days from the dating and signing of this Order.

IT IS FURTHER ORDERED, that all Respondents shall jointly and severally pay costs in this matter in the amount of **ONE HUNDRED DOLLARS (\$100.00)**. The costs of **ONE HUNDRED DOLLARS (\$100.00)** shall be submitted within one hundred twenty (120) days from the date and signing of this Order.

IT IS FURTHER ORDERED, that in the event the Respondent fails to timely submit payment of the forfeiture and costs as set forth above, the barbering and cosmetology manager's license for Donna J. Tallard (#81-9291) **SHALL BE SUSPENDED**, without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said costs has been paid to the Department of Regulation and Licensing and their failure to pay the costs shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED, that file 07BAC210, be and hereby is, closed as to Donna J. Tallard.
