PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Lisa M. Dupree (date of birth of January 12, 1976) is duly licensed in the state of Wisconsin as a barbering or cosmetology manager in the state of Wisconsin (license #28271-81). That license was first granted on April 30, 2000, and is current through March 31, 2009. The last address reported to the Department of Regulation and Licensing (hereinafter Department) by Ms. Dupree is 1340 Apricot Street, Wisconsin Rapids, Wisconsin 54494.
- 2. On November 16, 2007, Departmental Investigator Douglas Austin inspected Hair Experts, a licensed barbering or cosmetology establishment located at 2501 8th Street South, Wisconsin Rapids, Wisconsin.
- 3. During the November 16, 2007, inspection, Investigator Austin found Lisa M. Dupree renting booth space at Hair Experts. Ms. Dupree had a current manager's license, but did not possess an establishment license for the booth rental.
 - 4. On November 28, 2007, the Department granted an establishment license for Ms. Dupree's booth rental.
 - 5. In resolution of this matter, Lisa M. Dupree consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat.

sec. 454.15.

- 2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached stipulation pursuant to Wis. Stat. sec. 227.44(5).
- 3. Wis. Stat. § 454.08(1)(b) provides that except as permitted by rule, no person may practice barbering or cosmetology, aesthetics, electrology or manicuring in an establishment unless the establishment is licensed to provide that practice under sub. (2).
- 4. Wis. Administrative Code § BC 3.02(2)(b) requires the lessee of a chair or booth to hold a manager's license and an establishment license.
- 5. By the conduct referred to in Findings of Fact paragraph 3., Lisa M. Dupree has violated Wis. Admin. Code § BC 3.02(2)(b).
- 6. Wis. Stat. § 454.15(2)(i) provides that violation of Wis. Stat. chapter 454 or the Administrative Code promulgated under chapter 454 is cause for discipline.
- 7. By the conduct described in Findings of Fact paragraph 3 above, Lisa M. Dupree has violated Wis. Stat. chapter 454 and the Administrative Code promulgated under chapter 454.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that the barbering or cosmetology manager license of Lisa M. Dupree (#28271-81) is hereby REPRIMANDED.

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Ms. Dupree shall pay to the Department of Regulation and Licensing a forfeiture of FIVE HUNDRED dollars (\$500.00).

IT IS FURTHER ORDERED that Ms. Dupree shall pay costs in the amount of THREE HUNDRED dollars (\$300.00) in this matter.

Payment of the forfeiture and costs shall be submitted in eight (8) installments. The installments shall be submitted on the following payment schedule:

IT IS FURTHER ORDERED that in the event Lisa M. Dupree fails to timely submit any payment of the forfeiture and costs as set forth above, the barbering or cosmetology manager license of Lisa M. Dupree (license number 81-28271) SHALL BE SUSPENDED, without further notice or hearing until Lisa M. Dupree has complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
