PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Respondent **Angela T. Goetter** is licensed in the state of Wisconsin as a Barbering and Cosmetology Practitioner, having license # 82-82437. This license was first granted to her on 09/25/03 and is current through 03/31/09. The most recent address on file with the Department of Regulation and Licensing for Ms. Goetter is 1454 North Franklin Place, Milwaukee, WI 53202.

2. A complaint was received by the Department alleging that several individuals with barbering and cosmetology practitioner licenses were renting chairs at East Town Spa Inc. without having separate manager licenses and separate establishment licenses.

3. East Town Spa Inc. is a licensed barbering and cosmetology establishment located at 718 E. Wells Street, Milwaukee, WI 53202.

4. Pursuant to Wis. Admin. Code § BC 3.02(2), the owner of a barbering and cosmetology establishment may lease a chair to a licensed individual as long as there is a written lease agreement and the lessee holds a manager's license and an establishment license. This rule has been in effect since October 1, 2003, with a 1-year grace period for getting into compliance for any person renting a chair prior to the October 1, 2003 effective date.

5. Wis. Admin. Code § BC 3.02(2) requires, in part, that “the lessee of a chair or booth shall be responsible for ensuring that the leased chair or booth operates in compliance with ch. 454, Stats., and the rules of the board.”

6. On September 20, 2006, two investigators from the Department of Regulation and Licensing performed an unannounced inspection at East Town Spa Inc. Ms. Goetter was not present at the time of the inspection.

7. Follow-up investigation revealed that Ms. Goetter rented a chair from the owner of East Town Spa Inc. from March 2004 to August 19, 2008.

8. As of August 20, 2008, Ms. Goetter became an employee of East Town Spa, not a chair rental.

9. Ms. Goetter has taken steps towards obtaining her manager’s license. She has taken the manager’s exam and is awaiting her results.

10. During the period that Ms. Goetter rented a chair from East Town Spa, she did not have the required manager’s license or separate establishment license for a chair rental.

CONCLUSIONS OF LAW

1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. Respondent **Angela T. Goetter** has violated Wis. Admin. Code §§ BC 2.04(1) and BC 3.02(2)(b) by renting a chair from the owner of East Town Spa Inc. without having the required separate manager’s license and separate establishment license for her chair rental. As a result, Ms. Goetter is subject to discipline pursuant to Wis. Stat. § 454.15(2)(i).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. **Angela T. Goetter** (license #82-82437) be, and hereby is, **REPRIMANDED**.

2. **Angela T. Goetter** shall pay **COSTS** in the amount of **TWO HUNDRED DOLLARS (\$ 200.00)**.

3. **Angela T. Goetter** shall pay a **FORFEITURE** in the amount of **SEVEN HUNDRED DOLLARS (\$700.00)**.

4. Payment of the costs and forfeiture shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

5. Payment of the costs and forfeiture, which total **NINE HUNDRED DOLLARS (\$ 900.00)**, shall be made according to the following schedule:

5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Ms. Goetter's license. The Board in its discretion may, in the alternative, impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Ms. Goetter fails to timely submit any payment as ordered, then her license (# 82-82437) SHALL BE SUSPENDED without further notice or hearing until Ms. Goetter has complied with the terms of this Order.

6. This Order is effective on the date of its signing.
