On April 16, 2002, the Social Work Section (Section) issued its *Order Granting a Limited License* to William M. Wyatt. Under the terms of the Board's Order, Mr. Wyatt was required to practice under supervision, submit quarterly reports to the Section, and complete thirty (30) hours of continuing education.

On July 30, 2008, the Section reviewed the request of William M. Wyatt, L.C.S.W., for the return of his license as a clinical social worker without restrictions pursuant to the Section's Order. Therefore, based upon evidence of Mr. Wyatt's compliance with the terms and conditions on his license,

IT IS HEREBY ORDERED that all the limitations on the license of William M. Wyatt to practice a licensed clinical social worker in Wisconsin are lifted and he is restored to full licensure.
