On November 6, 2008, the Wisconsin Board of Nursing considered the application of Janina M. Kennebeck to re-register her license to practice as a licensed practical nurse. Based upon the information presented including the applicant's failure to complete the continuing education ordered by the Board pursuant to Final Decision and Order dated September 17, 1998, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for re-registration of the nurse license of JANINA M. KENNEBECK, L.P.N. (lic. # 32990) is hereby DENIED.

IT IS FURTHER ORDERED that the applicant must complete the continuing education required under her previous board order with a modification that 8 hours of workload management could be modified to 8 hours of priority setting or time management.

IT IS FURTHER ORDERED that the applicant shall submit proof of compliance with this order prior to petitioning for re-registration of her nursing license.
