ORDER GRANTING THREE MONTH STAY WITH MODIFICATION

On July 16, 2008, the Wisconsin Medical Examining Board considered the petitioner's request for a three month stay of suspension and a reduction in his drug screens. Based upon the information of record which shows that the petitioner is in compliance with his Board order dated June 16, 2004, , and that the reduction in therapy is supported by his therapist, the Board finds and enters the following:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the suspension of the medical license of Benjamin W. Begley, M.D. (lic.# 20-29405) is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for a reduction in his drug screens is GRANTED. The petitioner's screens shall be decreased to fifteen (15) screens per year.

This Order is effective upon the date of signing and shall be continuous from the date of the previous stay.
