On April 17, 2008, the State of Wisconsin Chiropractic Examining Board (Board) heard the testimony of Dr. Reek, received the arguments of counsel Kevin Milliken and reviewed the documentation presented in support of the request by Laroy D. Reek, D.C., for an order granting full licensure. The Board determined that Dr. Reek has met all of the conditions imposed by the Board in its Final Decision and Order dated February 23, 2006, and in its Order Granting Stay of Suspension and Imposing Limitations dated May 8, 2006.

Based upon the Board's review, IT IS HEREBY ORDERED that the license of Laroy D. Reek, D.C., to practice Chiropractic in the State of Wisconsin is hereby restored to full and unrestricted status.
