ORDER GRANTING PARTIAL MODIFICATION OF LIMITED LICENSE

On March 18, 2009, the Wisconsin Medical Examining Board considered the petitioner's for modification of the Board Order dated April 10, 2007, to approve a change in his health care provider, a reduction in the frequency of his urine drug screens and the removal of the limitation on his workplace setting. Based upon the information of record presented, the Board now finds and makes the following:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for modifications of the limited medical license of STEPHEN B. MASON, M.D. (lic.# 50257-20) to reduce the frequency of his urine drug screens is hereby GRANTED. The screens shall be reduced to fourteen (14) times per year.

IT IS FURTHER ORDERED that the request for approval of a change in health care providers is hereby GRANTED. David L. Alexander, a psychologist from Effectiveness Associates in Indianapolis, Indiana, is approved as the petitioner's new therapist.

IT IS FURTHER ORDERED that the request for a change in the limitation on the petitioner's workplace setting is deferred pending receipt of additional information relevant to this modification.
