On June 4, 2009, the Board of Nursing considered the applicant's request for waiver of the board-approved nurse refresher course requirement. The applicant intends to perform medical claims utilization reviews For an insurance company and not engage in clinical practice. Based upon the information presented which shows that the applicant's license expired in 2001 and she has not practiced nursing thereafter, the Board now finds and enters the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the reinstatement of a permanent limited practical nurse license for CAROL L. BAESEMAN, L.P.N. (lic. #8320-31) in lieu of completing the board-approved nurse refresher course is hereby DENIED. IT IS FURTHER ORDERED that the applicant remains eligible to receive a limited license to complete a board-approved nurse refresher consistent with the board's precedent for reinstatement of expired credentials. IT IS FURTHER ORDERED that if the applicant does not want to proceed further with her license application, she may receive a refund of the application fees.
