On May 19, 2009, the Board of Nursing issued Terri Hasse a limited license permitting her to practice only as a participant in a board-approved RN refresher course. The Order provided upon successful completion of the refresher course, Terri Hasse's license which she surrendered on November 2, 2001 would be full reinstated. Documentation of successful completion of a RN refresher course, in support of Terri Hasse's request for full licensure, was reviewed on November 20, 2009.
