The Pharmacy Examining Board considered this matter at its meeting on July 22, 2009.

BACKGROUND

On May 17, 2000, the Board issued a Final Decision and Order suspending Mr. Triscari's license to practice pharmacy. The Order provided that the suspension shall be stayed upon Mr. Triscari providing proof of compliance with the conditions of the Order, and that his supervising physician or therapist expressly support the specific modification sought, via a written recommendation.

On or about June 18, 2009, Mr. Triscari requested an extension of his three-month stay of suspension, last granted on March 4, 2009, and a reduction in his individual/group therapy sessions, as required by paragraph 2. b. (2) of the Order, from once every three months to once every six months. Based upon all the information of record, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Mr. Thomas M. Triscari's, request for a three-month stay of the suspension, of license #10029, to practice pharmacy in the State of Wisconsin, be and hereby is, Granted.

IT IS FURTHER ORDERED that Mr. Triscari's request for a reduction in his therapy sessions from once every three months to once every six months, be, and hereby is, Granted.

The effective date of this Order is July 22, 2009.
