On April 2, 2009, the Wisconsin Board of Nursing considered the petitioner's request for a stay of suspension pursuant to the Final Decision and Order dated July 7, 2000. Based upon the information which shows that the petitioner has not actively practiced as nurse for more than 5 years, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the petitioner shall be GRANTED a stay of suspension and a limited license for the sole purpose of completing a board-approved nurse refresher course.

IT IS FURTHER ORDERED that upon completion of the course and submission of proof thereof, the petitioner may request a further stay of suspension of her nursing license.
