ORDER DENYING FULL REINSTATEMENT

On June 4, 2009, the Board of Nursing considered the petitioner's request for full reinstatement of her registered nurse license pursuant to the Final Decision and Order dated September 6, 2001. Based upon the information of record showing that the petitioner has not fulfilled all of the requirements of the board order, specifically; she has not successfully passed a DHFS Rehabilitation Review, she has not submitted proof of compliance with the drug and alcohol screen protocol, and she has not completed five (5) years of continuous active practice under the order without relapse, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the license of JANICE S. RIESE, R.N. (lic. #125307-30) to practice as a registered nurse is hereby DENIED.

IT IS FURTHER ORDERED that petitioner shall sign up with the 1st Lab for random drug testing. Upon passage of the Rehabilitation Review and enrollment with 1st Lab, the petitioner may request a stay of suspension to fulfill the requirements of the order that remain in effect for a minimum of five (5) years from the date of the initial stay of suspension.
