ORDER RESTORING FULL LICENSURE

By its *Final Decision and Order* dated August 6, 2001, the Podiatrists Affiliated Credentialing Board (Board) limited David John Labadie’s license as a podiatrist. Under the terms of the Board’s Order, Dr. Labadie was required to comply in all respects with the integrity requirements contained in the settlement agreement between him and the United States of America entered into in December of 1999. Among other things, the Board’s Order provided that after five years of continuous active professional practice and upon evidence of continuous compliance with the terms and conditions of the settlement agreement, Dr. Labadie could petition the Board for a termination of all limitations on his license and the restoration of his full license.

On September 14, 2004, the Board considered Dr. Labadie’s request that all limitations on his license be terminated. His request was denied.

On February 17, 2009, the Board reviewed Dr. Labadie’s request for the return of his license as a podiatrist without restrictions pursuant to the Board’s *Final Decision and Order* of August 2001. Based upon evidence of Dr. Labadie’s compliance with the terms and conditions on his license,

**IT IS HEREBY ORDERED** that all the limitations on the license of David John Labadie to practice as a podiatrist in Wisconsin are lifted and he is restored to full licensure.
