On February 18, 2009, the Medical Examining Board considered the petitioner's request for removal of a portion of the limitations imposed upon his licensure by order of the Board dated November 21, 2003. Specifically, the petitioner requested an order finding that he has satisfied the requirement to complete the UW-CME Assessment and Education Program. The information presented shows that the petitioner has successfully completed the required program. Accordingly, the Board now finds and makes the following:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the portion of the limitations upon the medical license of the petitioner ELEAZAR KADILE, M.D. (lic. #20- 2048) to complete the UW-CME Assessment and Education Program is hereby removed based upon satisfactory proof of his completion of this requirement.

IT IS FURTHER ORDERED that the remaining limitations upon the petitioner's license set forth in paragraphs 1-7 of the Board's original order are not removed and remain in effective.
