The Dentistry Examining Board considered this matter at its meeting on January 7, 2009.

**BACKGROUND**

On January 7, 2004, based upon a Stipulation signed by the parties, the Board issued a Final Decision and Order that suspended and limited the license of Gregg A. Seyler D.D.S., to practice dentistry in the State of Wisconsin for an indefinite period of time.

At its meeting on January 7, 2009, the Board considered Dr. Seyler's request to remove the suspension and limitations placed on his license in the Board's January 7, 2004, Final Decision and Order. Based upon all the information of record, the Board orders the following:

**ORDER**

**NOW, THEREFORE, IT IS ORDERED** that the request to remove the suspension and limitations placed on the license (#2402) of Gregg Seyler to practice dentistry in the State of Wisconsin, as described in the Board's January 7, 2004, Order be, and hereby is, Granted.
