ORDER GRANTING STAY OF SUSPENSION AND MODIFICATION OF ORDER LS0510191PHM

The Pharmacy Examining Board considered this matter at its meeting on February 4, 2009.

BACKGROUND

On October 19, 2005, based upon a Stipulation signed by Mr. Kunde, the Board issued a Final Decision and Order suspending Mr. Kunde's license to practice as a pharmacist for an indefinite period of time. The Order provided that the suspension shall be stayed upon Mr. Kunde providing proof of compliance with the provisions contained in Sections C and D of the Order, and that his treater is of the opinion that he is able to safely practice pharmacy under the restrictions contained in the Order. At various times since the effective date of the Order, the Board granted stays of suspension of Mr. Kunde's pharmacist license.

On or about November 12, 2008, Mr. Kunde requested a stay of suspension of his license; reduction of his therapy sessions from once a month to once every three months, and an increase in pharmacist-in-charge hours from 16 to 24. The Board considered Mr. Kunde's request for a stay of suspension and modifications of the Order at its meeting on February 4, 2009. Based upon all the information of record, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the suspension of the license (#8830-40) of Robert J. Kunde to practice as a pharmacist is stayed for a period of three (3) months conditioned upon his compliance with the conditions and limitations set forth in the Order contained in the Board's Final Decision and Order, dated October 19, 2005.

IT IS FURTHER ORDERED that Mr. Kunde's request for reduction of his therapy sessions from once a month to once every three months, and an increase in pharmacist-in-charge hours from 16 to 24 be, and hereby is, granted.
