The Pharmacy Examining Board considered this matter at its meeting on February 4, 2009.

BACKGROUND

On December 6, 2006, the Board issued a Final Decision and Order suspending Mr. Moon's license to practice as a pharmacist in the State of Wisconsin for an indefinite period of time. The Order provided that Mr. Moon could petition the board for a stay of suspension after providing sufficient proof of compliance with the provisions of Sections C and D of the Order. On or about December 1, 2008, Mr. Moon requested a removal of the suspension. Based upon all the information of record, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that due to his failure to provide sufficient proof of compliance with the Board's December 6, 2006 Final Decision and Order, Mr. Moon's request for the removal of the suspension of license #10536 to practice pharmacy in the state of Wisconsin, be and hereby is, Denied.

IT IS FURTHER ORDERED that Mr. Moon may repetition the Board for a stay of suspension upon providing proof of compliance with the Board's Order.
