### PROCEDURAL HISTORY

On February 23, 2006, the Wisconsin Chiropractic Examining Board (Board) issued an Order revoking John W. Zastrow's (Petitioner) license. On May 28, 2009, the Petitioner submitted an application to the Department of Regulation and Licensing (Department) for a license. The application was referred to the Board for its review. At its August 13, 2009, meeting the Board considered the Petitioner's application for a license.

### FINDINGS OF FACT

- 1. The Board's Order dated February 23, 2006, requires the Petitioner to provide sufficient evidence to the Board that the cause of the revocation no longer exists when he requests a license.
- 2. The Petitioner did not provide any evidence to the Board that the cause of the revocation no longer exists. The Petitioner only filed an application with the Department.

### **ORDER**

THEREFORE IT IS HEREBY ORDERED THAT, John W. Zastrow's request for a license is denied.
