On February 26, 2009, the Wisconsin Board of Nursing considered the petitioner's request for stay of suspension and modification of the Final Decision and Order dated March 9, 2006, to allow her discontinue her practice as an advance practice nurse prescriber in the field of anesthesia, but to retain her privilege to practice as a registered nurse. Based upon the evidence presented which shows that the petitioner had a recent positive drug screen and has admitted a relapse to narcotic diversion at her workplace, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request by Julie A. Wilcox, R.N., (lic. # 108442-30) for a stay of suspension of her registered nurse license is hereby GRANTED.

IT IS FURTHER ORDERED that the stay of suspension of the petitioner's advance practice nurse prescriber certificate (APNP) shall be REVOKED and the suspension reinstated pursuant to the terms of paragraph 4 of the Board order dated March 9, 2006.

IT IS FURTHER ORDERED that the petitioner's board order shall be modified and limited as follows:

a) The petitioner shall not practice as a certified registered nurse anesthetist or in the field of nurse anesthesia.

b) The petitioner shall not have access to controlled substances in the workplace for administration to patients.

c) The frequency of the petitioner's random urine drug screens shall be at the frequency of fifty-six (56) screens per year.

This Order is effective upon the date of signing below.
