ORDER DENYING FULL REINSTATEMENT OF LICENSURE

On September 3, 2009, the Board of Nursing considered the petitioner's request for full reinstatement of his licensed practical nurse credential pursuant to the Final Decision and Order dated September 14, 2006. The request was submitted approximately three months after his prior request which was denied on June 12, 2009. The information of record shows that petitioner has yet to complete two years of supervised practice with quarterly work reports as required under the Board's order. Petitioner requested reinstatement without completing this requirement on the basis that he is encountering difficulty obtaining nursing employment due to the work reports requirement. Based upon the information presented the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of licensure for SCOTT M. FIRE, L.P. N. (lic. #305604-31) is hereby DENIED.

IT IS FURTHER ORDERED that petitioner shall not submit a petition for full reinstatement until he has completed two years of supervised practice with satisfactory quarterly work reports. Until such time as petitioner fulfills the requirements of the Board's order, he shall remain ineligible for full reinstatement of his nursing license.
