The Veterinary Examining Board considered this matter at its meeting on November 19, 2008.

BACKGROUND

On August 23, 2006, the Board issued its Final Decision and Order ("Order") reprimanding Dr. Van Over and requiring him to complete three conditions: (1) notify the Board of his intent to resume the practice of veterinary medicine in the State of Wisconsin at least 60 days prior to resuming practice, (2) complete a record keeping course offered by the University of Wisconsin School of Veterinary Medicine, preapproved by the Board, prior to resuming practice, and lastly (3) pay \$2,284.00 in costs within 180 days of the effective date of the Order.

On April 9, 2007, the Board suspended Dr. Van Over's license for failure to timely pay costs in this matter. On or about June 5, 2007, Dr. Van Over remitted the costs in full and thereafter petitioned the Board for full licensure. Based upon all the information of record, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED due to Dr. Van Over's payment of costs in full, and compliance with the remaining terms of the Order, that the license of Dr. James E. Van Over, #4350, to practice veterinary medicine, in the State of Wisconsin, be and hereby is, fully Reinstated.

The effective date of this Order is November 19, 2008.
