On October 1, 2009, the Wisconsin Board of Nursing, considered the petitioner's request for full reinstatement of his nursing license pursuant to the Final Decision and Order of the Board dated December 12, 2006. Based upon the information of record which shows that the petitioner has not attained five years of continuous professional practice in compliance with the Board order, the Board now finds and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the registered nurse license of DUANE OLLIE, R.N. (lic. # 114233-30) is hereby DENIED.

IT IS FURTHER ORDERED that petitioner's drug screens shall be decreased to twenty-eight (28) times per year plus one annual hair test. Petitioner is put on notice that he is required to have work reports submitted to the Department Monitor.
