### ORDER DENYING FULL REINSTATEMENT AND GRANTING PARTIAL MODIFICATIONS

On April 2, 2009, the Board of Nursing considered the petitioner's request for full reinstatement of his nursing license pursuant to the Final Decision and Order dated December 14, 2006. In the alternative the petitioner requested modifications to the order to discontinue the therapy requirement and to decrease the frequency of his drug screens. Based upon the information of record which shows that the petitioner has not attained five years of continuous professional practice in compliance with the terms and conditions of the order, the Board now finds and makes the following:

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the license of DUANE C. OLLIE (lic. #114233) to practice as a registered nurse is hereby DENIED.

IT IS FURTHER ORDERED that the petitioner's request to discontinue therapy and decrease his drug screens is GRANTED. IT IS FURTHER ORDERED that the frequency of the petitioner's drug screens is hereby decreased to forty-two (42) times per

The stay of suspension granted under the Board's original order is continuous and remains in effect until it is removed by the Board for non-compliance with the terms and conditions of the order.
