The Pharmacy Examining Board considered this matter at its meeting on February 4, 2009.

**BACKGROUND**

On February 7, 2007, based upon a Stipulation signed by Ms. Barth, the Board issued a Final Decision and Order suspending Ms. Barth's license to practice as a pharmacist for an indefinite period of time. The Order provided that the suspension shall be stayed upon Ms. Barth petitioning the Board and providing proof of compliance with various conditions set forth in the Order. In August 2007, the Board granted a continuous stay of the suspension of Ms. Barth's pharmacist license.

On or about January 22, 2009, Ms. Barth submitted a petition to the Board for the removal of the conditions and limitations placed on her license and return to full licensure. The Board considered Ms. Barth's request for return to full licensure at its meeting on February 4, 2009. Based upon all the information of record, the Board orders the following:

**ORDER**

**NOW, THEREFORE, IT IS ORDERED** that the conditions and limitations placed on the license (#13869) of Jill M. Barth to practice as a pharmacist, as set forth in the Board's Final Decision and Order, dated February 7, 2007 be, and hereby are, removed. Ms. Barth's license is returned to full licensure.
