On September 3, 2009, the petitioner appeared before the Board of Nursing in support of his request for full reinstatement and modifications to the Final Decision and Order dated August 30, 2007. Based upon the information present which demonstrated that petitioner has successfully completed a residential AODA treatment program in California but has not yet completed five years under the Board order, the Board now finds and makes the following:

ORDER

IT IS FURTHER ORDERED that an initial stay of suspension of the license of RICHARD J. WASCHBISCH, R.N. (lic. #90439-30) to practice as a registered nurse is hereby GRANTED.

NOW, THEREFORE, IT IS ORDERED that the petitioner's request for full reinstatement of licensure is DENIED.

IT IS FURTHER ORDERED that the petitioner's urinalysis screens shall be forty-eight (48) times per year with one additional hair test.

IT IS FURTHER ORDERED that attendance at Celebrate Recovery is approved in lieu of attendance at AA meetings.
